



## Part A:

## WHEREAS

- (a) The Student is desirous of pursuing the course of study in the Foundation Programme (hereinafter referred to as "the Course") at IUMW;
- (b) IUMW has agreed to grant the Student a Foundation Programme Scholarship (hereinafter referred to as "the scholarship") to pursue the Course for a period of one (1) year and the Guarantor hereto have agreed to guarantee the due performance of the obligations of the Student as stated herein.

**NOW IT IS HEREBY AGREED** as follows:-

### (1) OBLIGATION OF THE STUDENT

The Student hereby covenants with the IUMW that he/she shall:-

- (a) diligently pursue the Course and shall complete within the prescribed period of the Course or such longer period as may be approved by the IUMW;
- (b) shall pursue his/her undergraduate education in IUMW;
- (c) keep the IUMW informed of his/her last known address and notify the IUMW of any change of the address;
- (d) shall comply with the rules, regulations, policies and procedures of IUMW;
- (e) shall attend classes regularly, to complete classroom and academic assignments, and to observe the regulations of the IUMW at all time.

### (2) OBLIGATION OF IUMW

IUMW hereby covenants with the Student as follow:-

- (a) IUMW agree to provide the scholarship with the total sum of Ringgit Malaysia \_\_\_\_\_ (RM \_\_\_\_\_) per academic year (as stated in the SCHOLARSHIP DETAILS - Appendix A) as determined by the Executive Management Committee for the student to take up the Course in IUMW.
- (b) IUMW shall provide the scholarship in the form of tuition fee waiver for the Course EXCLUDING all costs with respect to transportation, insurance, passports, visas, personal spending money, and other expenses.
- (c) The scholarship granted for the Course is neither transferable to another candidate nor exchangeable for cash.

### (3) TERMINATION OF SCHOLARSHIP

IUMW shall have the absolute right to forthwith terminate the scholarship granted to the Student in the following event of default:-

- (a) the conduct or behavior of the Student is unbecoming to the IUMW and/or prejudicial to the rules and regulation of IUMW;
- (b) the student does not wish to continue or discontinue the undergraduate study in any course offered by IUMW;
- (c) the student is unqualified to enroll into any of the undergraduate programme offered by IUMW due to non-fulfillment of academic requirement.



In the occurrence of any event of default stated herein, the Student shall be required to commence repayment of all monies disbursed by IUMW within thirty (30) days after his/her withdrawal date from IUMW.

IUMW reserves the right not to issue any results / transcript / certificates in the event of student's non- fulfillment of the terms & conditions of this agreement.

IUMW shall have the rights to initiate a legal proceeding against the Student for any breach of the terms and condition stated herein.

#### **(4) GUARANTOR'S LIABILITY**

- (a) The guarantor, who shall be financially sound and no bankruptcy proceedings have been commenced against him/her, in consideration of the scholarship granted to the Student by IUMW herein before contained having been made at their request hereby covenant with the IUMW that the Student shall duly perform and observe all the covenants stated herein and that in the event of default of repayment by the Student under Clause (3) hereof or performance or observance of any of the covenants on the part of the Student as aforesaid, the Guarantor shall jointly and severally be liable to pay and make good to the IUMW on demand all the losses, damages, costs and expenses thereby arising or incurred by the IUMW, PROVIDED ALWAYS that it is hereby agreed that any neglect or forbearance of the IUMW to enforce performance or observance of the several stipulations herein on the Student's part herein contained and any extension which may be given by the IUMW to the Student shall not release or exonerate or in any way affect the liability of the Guarantors under this covenant.
- (b) It is hereby agreed and declared that if at any time during the continuance of this Agreement either or the Guarantor shall die or cease to reside permanently in Malaysia or remain out of Malaysia for more than twelve consecutive months or shall be adjudged a bankrupt or suffer financial hardship, this Agreement shall be binding their respective heirs, executors and administrators.

#### **(5) DURATION**

The agreement will be effective as soon as it is signed by the IUMW for a period of one (1) year.

#### **(6) GOVERNING LAW**

The validity of this Agreement and of any of its terms or provisions hereunder shall be interpreted and construed pursuant to and in accordance with the Malaysian laws.
